OTHER ITEMS LISTED BELOW

Hazardous goods not permitted:



Explosives e.g.: Ammunition, Christmas crackers snaps, Fireworks, Fuses etc

Gases e.g.: Aerosols, Compressed Air , Cigarette lighters, Gas Cylinder for camping stoves, Aqualungs, Chlorine, Fluorine, Fire Extinguishers etc

Flammable liquids & goods e.g.: Perfumes & Aftershaves, Lighter fluid, Matches (including safety matches) Paint thinner, Adhesives, Paint , Oil etc

All oxidizing substances & Organic Peroxides e.g.: Bleach etc

Toxic & Infectious substances e.g.: Pesticides, Insecticides, Mercury, Poisons etc

Radioactive Materials

Corrosive substances e.g.: All battery types, Corrosive cleaning fluids, Acids and Alkali's, Thermometers (mercury) etc

Miscellaneous Dangerous goods e.g.: Asbestos, Magnetized materials, Dry Ice, Self inflating life jackets

OTHER PROHIBITED & RESTRICTED GOODS

The following goods are classified as prohibited and not permitted in your shipment:

- Firearms, Weapons & Ammunition e.g.: Ammunition, Firearms (deactivated or otherwise), Air rifles, Knives, Swords
- Animals e.g.: In any form (dead or alive) including pets, birds or fish, Animal skins, Furs or Animal remains, Ivory products
- Foodstuffs & Plants e.g.: Alcohol , Frozen or refrigerated drinks unless they can be packed and carried untreated, all plants
- Tobacco & Tobacco Products

Items of exceptionally high value

- Antiques (comprising item(s) having special value because of age and/or esteemed for artistry, beauty or period of origin)
 - Works of Art (comprising drawings, paintings, sketches, tapestries, clocks, poetry and sculptures, all of which are admired for their aesthetic appeal)
- Other items including: Gold and Silver, Precious Stones, Jewellery and/or Watches , Unused Stamps, stamp collections of more than £50 value
- Unique items of exceptionally high value

Money & negotiable items

- Currency , Coins, Cheques, Bills of Exchange, Bonds, Savings Books, Pre-paid credit cards, Share certificates, Bullion, Other securities, Passports
- Pornographic materials
- Human remains or bodily fluids
- Illegal narcotics / drugs
- Items with inherent defects

CONDITIONS OF DELIVERY

We do not carry goods which are in our sole opinion dangerous goods including, but not limited to, those specified in the International Civil Aviation Organisation (ICAO) technical instructions, the International Air Transport Association (IATA) dangerous goods regulations, the International Maritime Dangerous Goods (IMDG) code, the European Agreement concerning the international carriage of Dangerous goods by Road (ADR) regulations or any other national or international rules applicable to the transport of dangerous goods.

We also will not carry any goods:

- 1. Which could damage property or any individual
- 2. Where carriage is prohibited by law in the country of origin, transit or destination
- 3. Which require special facilities precautions or permits

Compliance with government regulations or laws is the senders responsibility. Not all commodities can be sent to all destinations.

Restricted Items which will only be sent on a limited liability / non compensation basis only
